marble (or as Camden called it Lapis Obsedeamus) or touch stone. A square block excavated into a basin, placed upon a circular shaft of three large single stones with four circular pillars at the corners, without bases and having capitols of plain upright leaves. The bason is surrounded by a wreath of foliage and at two of the angles are birds, perhaps doves, putting their beaks into a vessel like a stone bottle surmounted by a cross. At the other two corners are foliage. These four corners are surmounted exactly as the Winchester font - on the south side is carved the creation of man, the formation of Eve from Adam(s side, and the eating of the forbidden fruit by both - on the west side the expulsion of Adam and Eve from paradise is represented by the Angel with a drawn sword, leading them from a magnificent porch or portal - and shown with a spade in his hand seeming to instruct Adam in the employment he was henceforth to follow, while Eve, who as well as her husband is here represented as decently apparalled, is exercising her distaff these porches convey the best idea of churches in the Saxon times than are now to be seen. The other two sides are ornamented with arches supported by single and double columns, and the frieze over them charged with dragon beast and birds.

The general information of the font — as well as the materials and dimension of it agree with that of Winchester. Fonts of the earliest date were capacious enough to admit of total immersion. Before the Reformation all were lined with lead, probably to prevent the porosity of stone from absorbing the water. A cover was provided for the generality of them, some of them very costly as that of Luton in Bedfordshire. They

were required to be kept fast by a lock for fear of sorcery

DESCRIPTION OF A FIGURE IN EAST MEON CHURCH on the wall of the South side of the Singing Gallery. The figure of a gigantic Stature, twelve feet in height and the other parts proportionable. It is represented in a reclining posture, supporting a female figure which appears to be placing a ball resembling a globe on his shoulders. One hand is placed on his side and the other holds a spear, the .... (unreadable - may be "boles") may have been richly ornamented but time and probably the effect of damp have nearly obliterated them, though conspicuous traces remain of what they were once. Various opinions have been offered respecting it but none are at present decisive. Mr. Digon said that in Catholic churches St. Christopher was sometimes represented in that manner, with Our Saviour on his shoulders, but it is probable that the smaller figure which is evidently female has not the least analogy to the manner in which Christ is generally represented, as his head is always surrounded with glory whereas this head has a cap similar to that worn by Bishops in the reign of Henry VII, Henry VIII and Edward VI.
